





# How to transfer money overseas

If you're living in Spain, you may need to move money out of the UK into your Spanish bank. This may be income from a pension, mortgage payments, or funds to cover living costs.

While there are many ways you can transfer money, some ways are better than others. In this article we look at what your foreign exchange options are, including tips on saving money and simplifying the process.



# What is foreign exchange (FX)?

Foreign exchange (FX) is when you transfer one currency, such as British pounds, into another currency, such as euros. You need to do this when you move money from one country to another.

The amount of money you get depends on the exchange rate. If the pound euro exchange rate is 1.10, you'll get €1.10 for every pound. So, the higher the exchange rate the more money you get.

The problem is that exchange rates are always moving. In October 2022, the GBP/EUR exchange rate moved between lows of €1.10 to highs of €1.16. If you were changing £200,000 into euros, that six-cent difference turns into a €12,000 difference.

In addition, some companies offer better exchange rates than others. That's why choosing the right company can save you a lot of money.



# Using a bank or a broker?

Many people use their high-street bank when they move money between the UK and Spain. However, currency brokers – companies that specialise in foreign exchange – often offer much better exchange rates.

Banks also tend to charge transfer fees, which can add up if you're moving money overseas regularly.

Another benefit of using a currency broker is that they offer more options for when and how you move your money. With a bank, you can often only make a transfer then and there. With a currency broker, you have many more options which can allow you to enjoy a much better exchange rate than you might otherwise get.
